AWARDS

1st Place and 2nd Place awarded to heaviest (3) bass stringer and the heaviest (7) crappie stringer. Tournament Teams can only weigh-in a fish stringer for either the bass or the crappie. No team can weigh-in for both. The heaviest bass and the heaviest crappie weighed in will receive an individual award.

Tournament Rules & Regulations:

- All Texas Parks & Wildlife regulations shall apply.
Life jackets must be worn with Kill Switch attached, when the boat engine is running.
All boats must be equipped with a working live well.
- Must follow all "Villages Marina" rules & regulations.
- Trailering will be allowed. You may launch your boat from any ramp on the lake. Ramp fees will be paid by Delek at the "Villages Marina" ONLY.
- Official start time is 6:00am, with your first rod cast at this time / Early weigh-in starts at 1:00pm and must be in line to weigh-in before 3:00pm.
- Only one rod may be used at a time per contestant.
- Only artificial baits can be used for bass.
- Artificial or live baits can be used for crappie.
- No fishing is allowed within 50 feet of another tournament boat, anchored or tied, unless both parties are in agreement.
- All decisions of tournament directors are final.
